Steels Creek Tennis & Social Club, Inc. Membership Policies:(2025-2026 membership year)

The Committee adopted the following policies -to be followed by members, guests and others:

- The Membership year runs 1 July through 30 June the following year.
- Fees
 - Social member (non-playing member) \$ 10.00/year
 - Senior member (playing members 17 years of age and over) \$ 45.00/year
 - Junior member (playing members under 17 years of age) \$ 25.00/year
 - Family Membership (playing and non-playing - may be mixed) \$ 120.00/year

Fees due from 1 July each year

Pro-rata fees (new members joining after 1 February - through 30 June)

- Social and Associate member (non-playing member) \$ 5.00
- Senior member (playing members 17 years of age and over) \$ 22.50
- Junior member (playing members under 17 years of age) \$ 12.50
- Family Membership (playing and non-playing - may be mixed) \$ 60.00

Key Fee (one time fee for new or replacement \$ 20.00 (key available only to life or senior members, not social or junior members - no more than one key per domicile.)

Fees for renewing members must be paid by 31 August or membership benefits (court use privileges, etc.) are suspended.

- Social members are non-playing members of the club.
- This means that if you use the courts for lessons, social evenings, or private play, you must pay to be a life, senior, junior or family member.)
- Family membership is two adults (playing or non-playing) and any number of children aged 17 years and under from the same household. Children 18 years and over are Senior members if playing or Social members if not playing.
- Exceptions are infrequent guests of an affiliated member using the courts or public playing on an Open Day.
